Kheda flogging is a case of 'police atrocity': top court

The Supreme Court on Tuesday orally observed that the 2022 incident of four Gujarat Police officers publicly flogging Muslim men after tying them to a pole for allegedly disrupting a garba event in Kheda district amounted to an "atracitu"

 The conduct of the four officers were found to be in contempt of the directions of the Supreme Court in the D.K. Basu judgment of 1996 against police abuse and custodial violence. The D.K. Basu verdict had highlighted the deep concern in a free society for the protection of an individual from torture and abuse by the police and other law-enforcing officers.

- Born on January 24, 1924, in the Nai samaj (barber society
- Thakur, who sacrificed his education for the freedom struggle, was arrested during the Quit India Movement from 1942 to 1945.
- During Thakur's Chief Ministership in 1977, the Mungeri Lal Commission submitted its report recommending that backward classes be reclassified as extremely backward classes and backward classes. The report was implemented in 1978. This paved the way for 26% reservation for them in government services in Bihar in November 1978.

Analysing the rising gap in incomes

Using data from the 2017-18 and 2022-23 rounds of the Periodic Labour Force Survey, this article examines the changes in income inequality amongst all income earners in India, and disaggregates it according to the nature of employment



According to a recent report by the State Bank of India (SBI), India has witnessed a significant fall in inequality over the last decade.

- Examining taxpayer data, the report claims that the Gini coefficient a standard measure of inequality that ranges from 0, indicating perfect equality, to 1, indicating perfect inequality has fallen from 0.472 in 2014-15 to 0.402 in 2022-23. A fall of almost 15% in the Gini coefficient indicates a significant reduction in inequality.
- The fall in the Gini coefficient is more or less empirically established by the SBI report, but this has been accompanied by polarisation in incomes.
- Such polarisation is not seen in taxpayer data since the bottom 10% do not earn enough to be included in the tax net.

Gini coefficient is a typical measure of income inequality.
 The coefficient varies between 0 and 1, with 0 representing perfect equality and 1 perfect inequality.

Sweden set to become NATO member as Turkey approves its membership bid

Turkey's parliament ratifies Sweden's NATO membership bid, clearing the biggest remaining hurdle to expanding the Western military alliance after 20 months of delay. Turkey's general assembly, where President Tayyip Erdogan's ruling alliance holds a majority, voted 287-55 to approve the application that Sweden first made in 2022. All NATO members need to approve applications from countries seeking to join the alliance.





- Formed in 1949 with the signing of the Washington Treaty.
- The North Atlantic Treaty Organization was created in 1949 by the United States, Canada, and several Western European nations to provide collective security
- NATO's purpose is to guarantee the freedom and security of its members through political and military means.
- POLITICAL NATO promotes democratic values and enables members to <u>consult</u> and cooperate on defence and security-related issues to solve problems, build trust and, in the long run, prevent conflict.
- MILITARY NATO is committed to the peaceful resolution of disputes. If diplomatic efforts fail, it has the military power to undertake <u>crisis-</u> <u>management</u> operations.
