#### **Key Reasons for the Growing ARC of Violence**

  - Discrimination, marginalization, and exclusion of certain groups can create a fertile ground for conflict and violence.
- Role of the Media: The media plays a crucial role in shaping public perception of violence. Sensationalism, biased reporting, and the spread of misinformation contribute to the perpetuation of violence rather than its prevention.
- **Political Rhetoric:** It plays a major role in normalizing aggression, as divisive speeches and inflammatory statements by leaders create an environment where violence is not only justified but sometimes even celebrated.
- **Environmental Degradation & Climate Change:** These can also contribute to violence, as competition for scarce resources intensifies.

  - The United Nations Security Council (UNSC) and the International Court of Justice (ICJ), once seen as pillars of global governance, are struggling to address the escalating violence.
- Ongoing Conflicts in West Asia: The war in Gaza and Lebanon has given a false impression of peace in the region. Subterranean activities are increasing, indicating that lasting peace is unlikely.
  - The region continues to be a hotbed of violence, with various factions vying for control.
- Extremist Violence and Global Implications: The rise of extremist ideologies, both right-wing and Islamist, has added layers of complexity to global security.
  - Countries worldwide are grappling with the challenges posed by these ideologies, which often transcend national borders and manifest in various forms of violence
  - Increasing attacks on military facilities and transport have also been reported in Pakistan, while isolated attacks have taken place in Bangladesh, Malaysia, Singapore and Thailand.
- **Resurgence of Islamist Terrorism:** The radicalization of individuals online has led to the emergence of decentralized terrorist groups that are harder to track and counter.
  - These groups are using modern technology, including artificial intelligence, to spread extremist ideologies and recruit new members. The weakening of major terrorist organizations like al-Qaeda and ISIS has not eliminated the threat; rather, it has forced these groups to adapt and evolve.

## **Impact on India**

- India, with its diverse and complex socio-political landscape, has not been immune to the ARC of violence. It has faced its share of internal conflicts, communal violence, and terrorism.
- However, recent data from the National Crime Records Bureau (NCRB) shows a decline in riot-related incidents, indicating that India is at its most peaceful in 50 years.
