

Army seeks inclusion of additional areas in Manipur under AFSPA

At a review meeting chaired by the Union Home Ministry on Wednesday, the Army sought the inclusion of additional police station limits in Manipur valley districts within the ambit of the Armed Forces (Special) Powers Act (AFSPA), a senior go-



India-EU FTA talks: Progress on dispute settlement, stalemate on rules of origin

IN THE first round of trade deal negotiations between India and the European Union after the EU College of Commissioners' visit to India last month, both countries made considerable progress in agreeing on the norms that will guide dispute settlement under the pact but failed to make a significant breakthrough on rules of origin, which help determine the national source of a product.

The report evaluates countries based on GDP, social support, life expectancy, freedom generosity, and corruption perceptions. Despite rapid economic growth, India's happiness score remains low.
